Policy letter academic education and science – Ministry of OCW

The Dutch ministry of Education, culture and science (OCW) has published a policy letter on the plans of the government for academic education and science. In this policy letter, Minister Dijkgraaf states his ambitions and provides an overview of the new funding tools for research and science in The Netherlands. For early-career scientist, the sections on '*Investments at the base*' (page 6-9) is specifically interesting. In these sections, Minister Dijkgraaf introduces the funding tools for early career researchers (starting- and stimulation grants). These grants will be available for all universities and faculties: for details on allocation of these funds, please contact the Research Support Office at your institute.

The Ministry will evaluate whether the funding tools achieve the aims to provide a good fundament for early career researchers.

Extension of temporary contracts after pregnancy leave

It appears that pregnant (postdoctoral) researchers on a temporary contract have difficulty in getting an extension of their contract (due to the WWZ). However, contracts can be extended on a temporary basis. The Dutch Parliament stresses that it is not the intention of the WWZ to prohibit extensions due to leave of absence. Despite the possibility to get an extension, in practice this is not always the case.

To address this issue, the AMC included a statement on this topic in their work agreement for temporary employees. If you would like to receive more information, please [let us know](#).
